The xVision® Video Converter Audio De-Embedder converts a 3G-SDI signal into HDMI and extracts audio channels 1 and 2 onto professional balanced XLR connectors, all in a rugged, tour-ready enclosure with built-in power supply. There are no settings to fumble with – it just works.

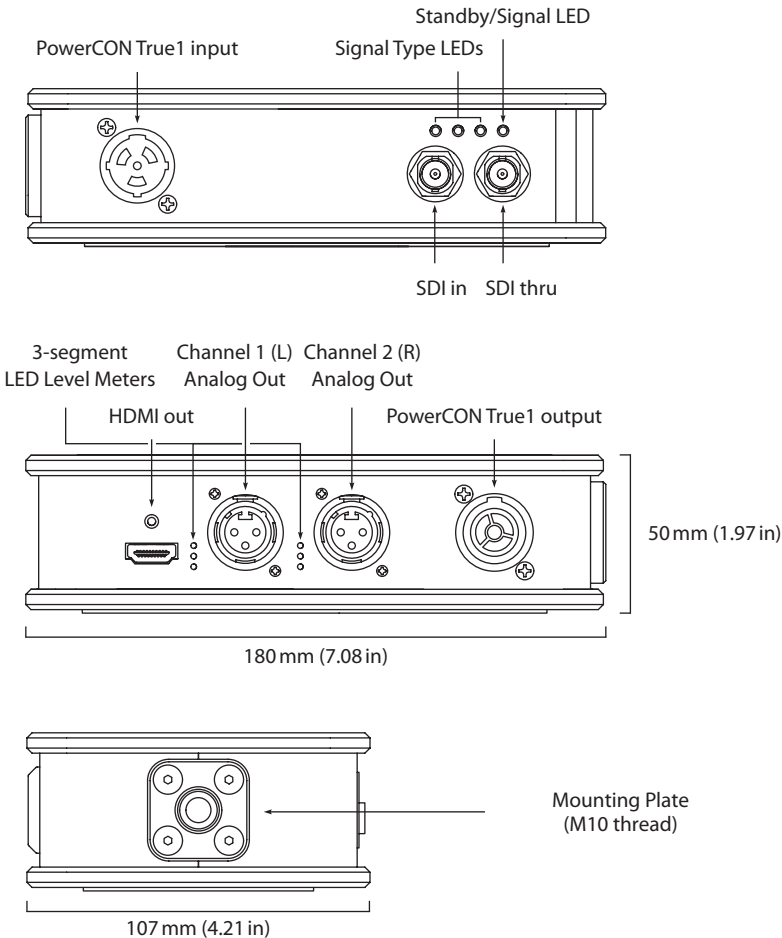
- The unit is intended for professional use only. Not for domestic use.
- Read and follow all instructions and information marked on the product or in this manual.
- Do not use this unit near water and clean only with a dry cloth.
- Install the unit in accordance with this manual.
- Do not install near any heat sources.
- Do not modify any part of the power cord. If the provided plug does not fit into your outlet, please consult an electrician.
- In the event the AC cable appears damaged, do not plug the unit in AC power and return it to your dealer for repair.
- Turn off the power before plugging or unplugging the PowerCon connector. The PowerCon has no breaking capacity and should not be connected or disconnected under load or live.
- Protect the power cord from being walked on.
- The Mains plug is used as the disconnection for the unit, it must remain accessible and operable.
- Unplug this unit during lightning storms or when unused for a long period.
- Servicing must be performed by a qualified and certified technician.
- Do not open the chassis. Opening the chassis will void the warranty unless performed by an authorized Theatrixx Service Center.
- Disconnect the AC Power Plug before moving the unit.
- Electrical grounding must be observed at any time to avoid electrical shock.
- Make sure that all devices plugged in the outlet connector of the device do not exceed 10A.

# 1. Unpacking

After opening the box, remove the unit from its protective plastic bag, and unpack the included accessory box. Ensure the package contains the following:

- xVision® Converter Audio De-Embedder, PowerCON True1 in/PowerCON True1 out
- DVI male to HDMI male cable with locking screw (1 meter)
- Edison Nema 5-15 Male to PowerCON True1 or CEE 7/7 to PowerCON True1 cable (1.5 meter)
- Warranty card
- This user manual

## **2. Installation**

The unit can be mounted in different ways using the threaded mounting plate on its side. Any standard C-clamp type device (sold separately) or bolt using a M10 thread may be used. The unit may also be placed on a stable horizontal surface with no other attachment needed. Using the built-in magnets, multiple units may be stacked easily.

## **WARNING**

- Never use the magnets as the sole attachment method. The magnets are designed to facilitate stacking and should not be used to attach the unit to metallic bulkheads.
- Always use rated mounting hardware and accessories to avoid fatal accidents.
- This product must be installed in accordance with the applicable installation code by a person familiar with the construction and operation of the product and the hazards involved.
- Make sure mounting hardware is attached securely to all components of the installation.
- Always use a safety cable to secure the unit in case the main attachment device fails.
- The mounting means of equipment intended for wall or ceiling mounting shall be adequate for min 50N.
- Authorities Having Jurisdiction should be consulted as to conformance with applicable building codes.

### 3. Operation

The unit has automatic input format detection and adjusts the output to match the input. The unit is not equipped with scaling technology and will not change the format of the signal in any way.

1. Connect unit to power and (if applicable) connect auxiliary equipment to the converter's AC outlet.
2. The unit will boot and LEDs may flash in a random sequence.
3. If no video input is detected, the Power/Signal LED will light up Red
4. As soon as a valid video signal is detected on the input connector, the Power/Signal LED will turn Green and the Signal Type LEDs will indicate the detected signal type (3G/HD/SD).
5. The output plugs become active immediately after a valid signal has been detected.

**TIPS:** 3-segment LED level meters indicate visually the presence and state of signal on the XLR analog audio outputs. The outputs are balanced and provide professional +4dBu level output.

The XLR plugs are mapped to SDI channels 1 and 2.

The HDMI output plug will also output the full 8 audio channels. No need to choose between HDMI and XLR!

#### **IMPORTANT NOTICE REGARDING HDCP**

The HDMI output of a Blu-ray player or other HDMI devices may have HDCP encryption intended for content protection. HDCP protection may be active only for certain video files, depending on the device. The HDCP standard only allows for HDCP encrypted material to be converted to another format if that format also supports HDCP and the material is re-encrypted. The only interface formats that support HDCP are HDMI, DVI, Display Port and UDI. SDI does not support HDCP and therefore the conversion from HDMI with HDCP to SDI is against the HDCP standard.

#### **Circumventing HDCP is against US law**

In order to convert from HDMI with HDCP to HD-SDI the HDCP encryption will have to be removed. Removing HDCP and outputting the signal in a different format that does not support HDCP is circumventing the copyright protection. Circumventing any form of digital copy right protection is prevented by the Digital Millennium Copyright Act (DMCA) and is against US law.
